- ✓ **Proposal** of start up of common activities and actions among member States, acceding and candidate Countries.

Put forward a working plan and report, as appropriate, to the Ministers of Public Administration and Better Regulation

#### Regulatory Impact Assessment - I

To launch a common action based on:

Separately assessing directives -- already assessed by the European Commission -- according to national procedures and standards, in order to:

- ✓ Provide the Commission towards a first evaluation of the action plan;
- ✓ Analyse methodologies and approaches at Commission and Member States level and their interaction;
- ✓ Compare common points and proceed with the elaboration of a RIA Common Framework at EU level.





#### Regulatory Impact Assessment - II

To launch a common action based on:

Separately assessing according to national procedures and standards, national measures, with a specific impact on business and competitiveness (e.g start up of business, shops opening hours) in order to:

- ✓ Analyse and exchange good practices through the expertise of the countries that have a RIA procedure;
- ✓ Compare common points and proceed with the elaboration of a RIA Common Framework among EU Member States.





### **Simplification**

Presentation of national Simplification programs and policies, focusing in particular on:

- ✓ Procedures related to the start up of productive activities (impact on enterprises)
- ✓ Procedures related to specific life events (citizens)
- ✓ Structures, instruments, methodologies and time frame that have been set up

Concrete suggestions for EU's simplification program and proposals for the identification of possible indicators





### Training on Better Regulation

Encouraging and improving joint training programs, workshops and seminars at EU level for officials on better regulation







#### Performance Indicators

Consider how indicators of performance in relation to Better Regulation might be progressed at National and European level, in order to:

- compare the performance of Member States and of the Commission
- look at progress over time
- identify particular areas of difficulty

- ✓ monitoring the implementation of the Commission's Action Plan;
- ✓ providing a forum for member States to exchange experiences and discuss new developments in the area of better regulation.
